 - Steve Brundle, Licensee of the Golden Fleece, informed the council that the Captains Table site was still the subject of a legal dispute and nothing was likely to be done to tidy the area until the dispute was resolved. He also informed the council that Hayley, the lady that had regularly sang from the balcony of the Fleece had recently performed at the London Palladium, having been discovered as a direct result of singing at the Fleece. The complaints made to the District Council about the singing had not been upheld.

The Clerk explained that since the 1st April, when the Town Council have no longer been able to use the district council wheelie bins behind the Beach Road toilets, the amount of waste generated on the playground over the weekend periods has been sufficient to fill three I100lt wheelie bins. As the season progresses it is likely that between four and six wheelie bin loads will be generated each week at a cost to the Town Council of approximately £3000 annually. Practically all the waste is fish and chip packaging.

<u>Resolved</u> – To remove the litter bins from the playground for a trial period of a month.
