

Recommendations from Traffic Management Working Party for changes to Parking Restrictions.

The existing parking restrictions for Wells are detailed in the following document:

“The Norfolk County Council (Wells-next-the-sea, Various Roads) Prohibition of Waiting Order 2013”

- The working party have recommended the following changes to Schedule Three of the existing order:

That all the ‘At Any Time’ seasonal restrictions listed in Schedule Three should be changed to be in force all the year round and not just between Good Friday to 30th September.

- The following recommendations have been made for Schedule Four:

That all the seasonal restrictions in Schedule Four should be in force all year and not just Good Friday to 30th September.

That the seasonal restrictions on the Glebe and Northfield Lane should be changed from 0800 – 2000 to being in force all day all year.

- The following additional restrictions are requested:

Bolts Close – To continue the existing ‘No Waiting at Any Time’ restriction, on the western side at the southern end of Bolts Close, north approximately 20 meters to a point just beyond the entrance to Paradise House.

Burnt Street – To continue the ‘No Waiting at Any Time’ restrictions from Church Plain west along Burnt Street, on the northern side, through the narrows to the bus stop.

Clubbs Lane – To add new ‘No Waiting at Any Time’ restrictions outside Scarborough House for the whole frontage on the eastern side.

Marsh Lane – For the existing ‘No Waiting at Any Time’ restrictions at the western end of Marsh Lane to be continued east on both sides (approximately 60 meters) through the narrows to a point outside 12 Marsh Lane.

Northfield Lane – To continue the existing ‘No Waiting at Any Time’ restrictions at the top of Jolly Sailors Yard east along Northfield Lane (northern side) approximately 50 meters to the junction with Northfield Way.

Northfield Lane – To add new ‘No Waiting at Any Time’ restrictions at the mouth of Northfield Avenue and along Northfield Lane through the narrows on the southern side to the junction with Knitting Needle Lane.

Polka Road – To continue the existing ‘No Waiting at Any Time’ restrictions from Church Street north along the western side of Polka Road to the Zebra Crossing.

Polka Road – To add new ‘No Waiting at Any Time’ restrictions along the western side of Polka Road from a point north of the entrance to Shrublands, south down Polka Road, to a point south of the entrance to The Old School.

Polka Road – To continue the existing ‘No Waiting at Any Time’ restrictions on the eastern side of Polka Road north from Warham Road to a point just beyond the entrance to ‘Hirael’.

Southgate Close – To add new ‘No Waiting at Any Time’ restrictions on both sides of Southgate Close into Mill Court.
